The Special Meeting was called to order by the Chairman, Commissioner Hersh at 5 p.m.

Those Present: the Chairman, Commissioner Hersh; the Secretary Commissioner Lazinger, Commissioners: Peterson, Lebo, Barrett, Stone, Chief MacNamara, D/C Lyddy.

Motion by Commissioner Peterson; seconded by Commissioner Lazinger to go into Private Executive session to conduct police candidate interviews; carried unanimously.

Motion by Commissioner Peterson; seconded by Commissioner Barrett to adjourn the Private Executive Session at 9:03 p.m. and reconvene the Public Session at 9:04; carried unanimously.

Motion by Commissioner Peterson; seconded by Commissioner Hersh to offer a conditional job offer to Michael Fisher; carried unanimously.

Motion by Commissioner Peterson to extend conditional job offer to Brian Griffin. No second. Motion dies.

Motion by Commissioner Barrett; seconded by Commissioner Lebo to offer conditional job offer to Felix Gonzalez; carried unanimously.

Commissioner Barrett moved to offer conditional job offer to Thomas Jones; seconded by Commissioner Peterson. All those in favor except Commissioner Lebo voting no. carried unanimously.

Commissioner Barrett moved to make Felix Gonzalez, #1; seconded by Commissioner Stone. All in favor except Commissioner Peterson who voted no. Motion carries.

Commissioner Peterson moved Michael Tomanelli on list for further consideration given opportunity for re-interview in the future; seconded by Commissioner Barrett. Vote: Commissioner Lazinger, and Commissioner Lebo, Commissioner Hersh voting No; Commissioners Stone, Peterson, Barrett in favor; Tie vote: motion fails.

Commissioner Lebo moved Michael Tomanelli – conditional job offer; Commissioner Peterson seconded. Discussion. Commissioners Lebo, Peterson, Barrett, voting yes; Commissioners Lazinger, Stone, Hersh voting No. Tie vote: motion fails.

Motion by Commissioner Peterson; seconded by Commissioner Barrett to move Michael Tomanelli for future consideration. Vote: Commissioner Hersh and Lazinger voting No. Commissioners: Barrett, Peterson, Lebo, Stone voting yes, motion carries.

Motion by Commissioner Peterson to remove from consideration Candidate Young; seconded by Commissioner Lebo. Commissioners Hersh, Lazinger, Barrett, Stone, Lebo voting No. Commissioner Peterson voting yes. Motion fails.

Motion by Commissioner Lebo to move Fisher to #2 on the list; seconded by Commissioner Barrett. Vote: carried unanimously.

Motion by Commissioner Barrett to move Jones to third offer on the list; seconded by Commissioner Lazinger. Vote: Commissioner Lebo voting No; Commissioners: Lazinger, Peterson, Stone, Barrett, Hersh voting yes. Motion carries.

Commissioner Peterson moved to remove from consideration the following: Cole Ashker, Iris Will, Wayne Brelsford; seconded by Commissioner Lebo; carried unanimously.

Motion by Commissioner Lebo; seconded by Commissioner Peterson to have M. Tomanelli remain on list for future consideration. Never moved.

Motion by Commissioner Peterson to offer a conditional job offer for future to Brian Griffin; seconded by Commissioner Barrett. Vote: Commissioners Hersh, Lebo voting No. Commissioners Barrett, Peterson, Lazinger, Stone in favor; motion carries.

Motion by Commissioner Barrett moved Justin Young be offered a conditional job offer; seconded by Commissioner Lebo. Vote: Commissioners Lazinger, Peterson voting No. Commissioner Barrett, Lebo, Hersh, Stone voting yes, motion carries.
