

FAIRFIELD BOARD OF POLICE COMMISSIONERS

REGULAR MEETING

APRIL 13, 2016

The regular meeting of the Board of Police Commissioners was called to order by the Chairman, Commissioner Hersh at 4:30 p.m.

Those present: the Chairman, Commissioner Hersh, Commissioners: Stone, Barrett, Lebo, Peterson, Cafferelli, Chief Macnamara, D/C Lyddy, Capt. Smith.

The Pledge of Allegiance was recited.

The minutes of the previous meeting were approved on a motion by Commissioner Barrett; seconded by Commissioner Stone; carried unanimously.

Commissioner Peterson was made Acting Secretary on a motion by Commissioner Stone; seconded by Commissioner Lebo; carried unanimously.

Old Business - #8 Bloomfield Drive (originally surveyed on 2/24/16) was then discussed. Mr. Wendt addressed the Commission with regard to the recommendation of Mr. Galante to change the 2 Yield signs to Stop Signs. He also instead requested that Bloomfield be made a 4 way stop at the v area of the road where the exit driveway would be for the development. Motion by Commissioner Peterson; seconded by Commissioner Barrett to endorse the request by TP&Z for the 4 way stop on Bloomfield as discussed. Vote: Commissioner Lazinger recused himself. Commissioners Peterson, Barrett, Stone, Lebo, Cafferelli; motion carries.

Motion by Commissioner Lazinger; seconded by Commissioner Barrett to add Animal Control donations to agenda; carried unanimously.

Donations: animal control: Claire O'Toole \$50.00; Erik Priede \$25; Kudith Bodie \$25; Tara Bainer \$458. Motion by Commissioner Peterson; seconded by Commissioner Stone to deposit funds into the donation account; carried unanimously.

The Monthly Report was presented.

Commissioner Peterson withdrew as acting secretary, and Commissioner Lazinger resumed the duties on a motion by Commissioner Lebo; seconded by Commissioner Barrett; carried unanimously.

Motion by Commissioner Stone; seconded by Commissioner Lebo to adjourn and go into Private Executive Session to review police applicants: Cook, Colwell, Festa, Zerella at 4:45 p.m.; carried unanimously.

Motion by Commissioner Peterson; seconded by Commissioner Barrett to adjourn private executive session and reconvene public session at 8 p.m.; carried unanimously.

Motion by Commissioner Lazinger; seconded by Commissioner Lebo to offer conditional job offers to Michael Zerella and Michael Colwell; carried unanimously.

Meeting adjourned at 8:14 p.m. on a motion by Commissioner Peterson; seconded by Commissioner Barrett; carried unanimously.
